Call to order by Chair Karolyn Bartlett at 9:30 a.m.

Public Meeting Notification read by Bartlett.

**Motion:** (Skoug/Moen) to approve agenda for June 22, 2020 DHHS Board meeting. Carried. NOTE Change: John Muench will not be at the meeting; therefore, there will not be a Child Support update.

<u>Motion:</u> (Banks/Knutson) to approve minutes from the May 26, 2020 Health and Human Services Board meeting. Carried.

Comments from the Public: None

<u>Financial Reports:</u> Syvinski presented 2020 financial reports and a 5 year analysis on DHHS & Child Support.

<u>COVID-19 Update – Laura Sauve:</u> Sauve reported that Barron County has had a total of 30 cases as of date, with several of those cases coming from the previous week from another county contact. They will be an increase in funding for COVID 19 coming from the State. Plans for the funding will be for future vaccinations, added staff to accommodate and testing. Frolik reported that there is a COVID administrative meeting, held on Monday's, to discuss how purchases and expenses will be made regarding the funding. Sauve reported that we have enough supplies. Public Health is following the Badger Bounce Back Phase II plan allowing the increase of gatherings in size.

<u>DATCP and DSPS Licensing Fee Recommendation:</u> Sauve presented the proposed Environmental Health and Sanitation Fee increase and reasons for increasing fees, reducing or not changing the fee. Discussion followed.

**Motion:** (Knutson/Albrecht) to leave fees as is. If an establishment does not renew their license at renewal and decides to drop their license, they will receive a letter of the cost of not reopening.

<u>Methamphetamine Update:</u> Frolik presented on methamphetamine cost comparisons for 2018-2019. Areas of change were seen in therapy costs in 2019, which shows more treatment and support services were offered. COVID 19 is impacting the number of cases comparable to 2019. We have seen a high level of methamphetamine in the County, along with opioids. DHHS receives referrals

from the community and police departments. Frolik will be presenting at the July County Board meeting on methamphetamine.



Domestic and sexual violence has no barriers. It touches many lives indiscriminately. Embrace welcomes, respects and serves children, teens, adults and seniors regardless of gender identity, ethnicity, religion, sexual orientation, socioeconomic status or ability. We stand as allies with others in the pursuit of justice and equality. We wholeheartedly seek accountability for marginalization, oppression and hatred. Our offices and shelter are a safe space.

#### What is Domestic Violence?

Domestic violence is a pattern of behavior used to establish and maintain power and control in a relationship. Abusive behaviors may include physical acts, sexual violence, neglect, verbal and emotional abuse, stalking, and financial abuse. These behaviors can be used by intimate partners, dating partners, parents, caregivers, roommates, and other family members.

#### What is Sexual Violence?

Sexual violence is when someone forces or manipulates another person into any unwanted sexual activity without their consent. Consent is when someone actively agrees to sexual activity with another person at each step of physical intimacy. "Yes" can be expressed through words or actions that create a mutually understandable permission. Silence or the absence of a "no" is not consent. Consent can never be given under pressure, while asleep or in another vulnerable position, or obtained through emotional manipulation. Someone who cannot make rational, reasonable decisions because they lack the capacity to understand the "who, what, when, where, why or how," of the situation cannot consent. Sexual violence can be physical or verbal, like unwanted sexual attention or harassment. A perpetrator can be an acquaintance, family member, intimate partner or spouse, trusted individual, or stranger.

Domestic and sexual violence are serious public health problems which affect everyone in our communities—and, it's preventable!



Professional staff provide services 24 hours a day, 365 days a year to survivors of domestic violence, intimate partner violence, child abuse, and sexual violence. Embrace is also a resource for survivors' families, friends and partners who want to learn more about providing support.

Providing crisis intervention, advocacy-based counseling and referrals to community resources 24 hours a day, 365 days a year.

Interpreter services are available for survivors interpreter at no cost to you.

## Personal Advocacy & Crisis Counseling

Staff provide advocacy and counseling services that empower survivors with information and options to reduce barriers to safety, make informed decisions, and meet their own goals. Embrace creates a safe place where survivors can feel, share, and be heard without being judged. Services are tailored to each person promoting self-awareness and an understanding of the impact of trauma.

## Legal Advocacy & Accompaniment

Assistance filing restraining orders, preparation for court hearings and support during the hearing are some of the legal advocacy services provided. Embrace also provides accompaniment advocacy to law enforcement and prosecution interviews, child forensic interviews, and we work with survivors to help them understand their rights when navigating the civil and criminal court systems.

### **Medical Advocacy & Accompaniment**

Advocates are available to accompany survivors in the healthcare setting and give support through a forensic evidence collection exam after an incident. Advocates are there for emotional support and non-judgmental options counseling that help to protect a survivor's legal rights and safety.

## Community Referrals & Systems Advocacy

Embrace offers up-to-date information on services provided by other agencies. Staff advocate with local agencies to ensure a survivor's voice and needs are heard. Embrace coordinates county-specific collaborative response groups, offers education, and encourages partnering agencies to take a trauma-informed approach in serving all people. Staff engage our community members and advocate that the harm a survivor experienced be repaired to the greatest extent possible. Embrace seeks to change what institutions and communities do that worsen or fail to improve the situation survivors face.

## **Supportive Community**

Embrace advocates facilitate regular interactive meetings and events for survivors who have experienced domestic and/or sexual violence. These meetings help survivors realize they are not alone and offer an encouraging and non-judgmental environment to build connections to support healing. Family, friends, partners and other support people are welcome to attend too. The groups are completely confidential, respectful and a supportive community for all survivors of domestic and sexual violence.

## Community Outreach & Prevention Education

Embrace staff are available to present on a wide range of topics related to domestic and sexual violence to businesses, organizations, school classes and other community groups.

- Prevention Education training for preschool, grades K - 12 and college students offered at a developmentally appropriate level.
- In-Service Training training for professionals, community agencies, faith groups and other community groups on responding to survivors and connecting them to resources.
- Community Awareness information tabling and outreach activities at community events.

## Youth Programming

Tailored safety planning, crisis counseling, and prevention education are available that strengthen and support families by promoting healthy parentchild interactions. Embrace also offers Connected Kids, a violence prevention and resiliency building program, and a Safe Exchange Program that gives parents, guardians and their children a safe and stress-free place to do a custody exchange.

- On-site Counseling advocacy-based counseling, emotional support, and education on resources and options for students in local schools.
- Student Groups available in local schools focused on healthy relationships, self-esteem, positive coping mechanisms, and effective communication.


#### Safe Shelter

Safe housing and individualized case management services are available. There is a separate room and bathroom that gives survivors, regardless of their gender identity, the space and time they need to heal. Shelter space is handicap accessible.

## Other Programs

Seeking Safety, an evidence-based program held individually or in groups to help people understand and heal from co-occurring trauma and substance abuse, No Contact Dropping Course to discuss your legal rights with an advocate if you're a victim of a crime, Domestic Abuse Response Team, Sexual Assault Response Team, and Prison Rape Elimination Act Response. Transportation and childcare assistance may be available for survivors receiving services.



Embrace's expansion of outreach, awareness, and proactive systems advocacy efforts offered in the community allowed Embrace to reach and serve 242 Barron County residents. 15 percent of survivors served in-person accessed safe shelter services, and 114 of the 242 survivors also received advocacy services for the sexual violence they experienced.

## Top Five Most Common Direct Services

Men, women, and children in Barron County are most frequently using Embrace's trauma and options counseling, crisis intervention, support group counseling, referrals to other supports, and personal advocacy which includes assistance navigating various resource systems such as public benefits, housing, and providing transportation.







## Counseling & Advocacy


In 2019, Embrace's limited, part-time staff in Barron County served more survivors than in each of the previous three years. Embrace's 2019 transition and expansion plan met the immediate needs of survivors and allowed Embrace to significantly strengthen out-patient-based services and systems advocacy with community partners throughout the County. Embrace secured additional federal and foundation funding to increase the number of staff devoted to providing services and evidence-based programs for Barron County in 2020. Barron County Department of Health and Human Services' ongoing, unrestricted financial support ensures Embrace can retain its high-quality professional staff who have the respected expertise to work collaboratively with survivors and community partners enhancing services and closing the gaps in the systems.

New 2019 Programming for Barron County

Holistic services including crucial prevention education programming are now offered throughout the County to ensure every survivor receives the services they deserve and can be empowered to end the cycle of violence in their lives.








Evidence-based group curriculum addressing trauma and substance use and one-on-one advocacy services in place and regularly accessible for survivors at the Barron County Jail

# 36 survivors at high-risk of homicide received 1,005 nights of Safe Shelter




Barron County Adults Age 18-59 (41.67%) Barron County Children & Teens (52.78%)
