The Solid Waste Management Board meeting was called to order by Chair Schradle at 10:00 a.m. on Tuesday, September 6, 2022.

French confirmed compliance with public meeting notification.

Special Matters and Announcements (Non-Action Items): French has been in contact with US Senators to gain information on possible green energy grants within the Inflation Reduction Act.

Motion: (Olson / Hanson) to approve the agenda. Carried

Public Comment: None

Motion: (North / Rogers) to approve the minutes of August 2, 2022. Carried

2022 Financial Update: Busch reviewed the 2022 financials for Recycling and Waste to Energy through July. No concerns with the Recycling Fund. Waste to Energy is still showing a deficit but expected to level out by the end of year. Bohn reviewed items that are affecting the bottom line. Discussion.

2023 Budget: Bohn and Busch reviewed the Recycling and Waste to Energy budgets for 2023. Bohn reviewed plans for sale of recyclable materials. There are three (3) manned sites currently in operation. Discussed issues with maintenance and staffing at the sites. Waste to Energy revenues were reviewed with potential drops in steam and electricity sales. Changes in expenses were reviewed. Bohn reviewed capital purchases. There are no major capital projects expected for 2023.

**Motion:** (Olson / Gores) to recommend the 2023 Recycling and Waste to Energy budgets to the County Board. Carried

Cancellation of Demolition Charges for Highway Facility: Bohn gave an update on the concept of waiving the fee for the demolition materials from the Highway Department construction. The amount is currently about \$2,000. Discussion. Consensus to not forgive the amount and re-evaluated later, if necessary.

Staff Reports & Updates

- Acid Gas Removal System RFP: Bohn is expecting 2 bids to be received at the closing next week. Friday, September 16th will be bid opening. Staff will review and report back at the next meeting.
- Staffing Update: Bohn gave an update on recent staffing changes. Clerical staff has been replaced. There are still positions that are unfilled.
- Xcel Energy Power Purchase Agreement: Bohn is working with the Public Service Commission on moving forward.
- Air Emission Compliance Testing: Testing was completed last week. Results will be received in about a month.
- WTE / Recycling Compliance Inspection: Inspection will be held next week. No concerns anticipated.

Review Voucher Edit Lists: Reviewed expense for tires shipped out.

Suggestions for Future Agenda Items: acid gas removal system, Xcel Energy power purchase agreement
