# BARRON COUNTY MULTI-HAZARD MITIGATION PLAN UPDATE 4/27/23 STATUS REPORT

#### **Progress**

- Today is Meeting #3 with Steering Committee. Keep shorter, but add a meeting this summer.
- Meetings with all cities and villages complete.
- Town survey distributed 13 returned to date (February presentation cancelled)
- Public Education Institutions invited to participate. Following completed online survey:
  - o Barron Area School District
  - Cameron Area School District
  - o Turtle Lake School District
  - Northwood Technical College
- 4/25 Meeting with Barron Electric Cooperative
- 4/26 Survey distributed to Fire Chiefs
- Other stakeholder interviews underway. Multiple County meetings on May 8<sup>th</sup>
- Continuing with plan document development; most general research & data update completed.
- Overall, behind original schedule. All meetings/interviews not yet completed, so have not yet compiled mitigation alternatives for your consideration.

May

- send mini-plans to cities, villages, & participating schools
- send mitigation alternatives homework to Steering Committee (& others?)

June

- mitigation alternatives homework completed
- WCWRPC completes initial draft plan; provides key sections to Steering Committee and for review

- Steering Committee Meeting #4 (abt 60-90 minutes)
- review any key findings from interviews and meetings
- discuss/finalize mitigation strategy recommendations
- review other plan sections & discuss any other plan changes

Late July

- WCWRPC finalizes draft plan
- notice published for 30-day public comment period on draft plan

Note: Per the grant agreement, the draft plan must be provided to WEM by 8/31/23 and approved by FEMA by 11/30/23, unless an extension is requested & approved.



August draft Plan to WEM for initial review → modify plan if needed

Sept-Nov County Board adopts the plan → obtain FEMA approval

Oct-Dec City, Village, & School/College adoptions → obtain remaining FEMA approvals

(approvable pending adoption, once County adopts)

Nov-Dec Print & Distribute Final Plan (once all adopted & FEMA approval letters received)


# A Few Highlights from Meetings & Surveys to Date

Flooding – Increasing heavy rain events-> greater stormwater flooding concerns.
 Monitor limited overbank/riverine flooding; mostly over roads and culverts. Some damrelated comments.

- Tornados & Severe Weather 2019 storms; "Mike has damage reports." Increasing interest in safe rooms, especially for mobile home parks, campgrounds and resort properties. Remote unlock opportunities. Sirens for lakes and rural development areas; some aging municipal and/or lack battery back-up.
- Winter Storms & Extreme Cold Increasing ice & snow loads. Power loss largest concern. Barron Electric continuing to bury lines. Travel and drifting, but no mitigation actions noted.
- Power Outages Overhead lines in wooded lake areas more prone. Generator needs for critical facilities remains high, but some significant improvements. Emergency fuel access during outage.
- Extreme Heat & Drought Generally, not a high priority. Local communities may not be aware of available heating/cooling shelters. Include shelters as part of new safe room grants.
- Wildfire Generally, not a high priority. Ensuring emergency vehicle access. Some dry hydrant needs.
- **Cyber-Security** Improved awareness and diligence overall. Remote monitoring vs. control of equipment/infrastructure.
- **Haz Mat Spills** Generally, transportation-related greater concern than fixed sites. Fuel, LP, & Anhydrous supply/transfer stations. PFAs.
- Active Threats Growing attention and some hardening as municipal buildings improved. Infrastructure vulnerabilities. "Check with Mike."
- Pandemic/Zoonotic Avian Flu. Per communities, no major actionable items or lessons learned from COVID-19. Hard on nursing homes. Increase in remote working and meetings.
- Education & Training Promote Code Red. Some NOAA radio interest, but waning.
  Interest in more information on how emergency/disaster recovery funding works (e.g.,
  processes, lessons learned). Public works training on resources, protocols, and



- collaboration/mutual aid. Joint exercises with major employers (e.g., schools, manufacturing, hospitals, casino).
- Other More EOPs are up-to-date. Schools, nursing homes and assisted living most frequently mentioned vulnerable population. Some ESL. Who are VOADs (and do communities contact directly)?
