A call to order was made by Timm at 12:15pm.

CONSENT AGENDA

The May 2023 board meeting minutes and financials were reviewed. Motion by Aaron, second by Jenny to approve the minutes. Motion carried. Motion made by John second by Ray to approve the financials. Motion carried.

COMMITTEE REPORTS

The executive team approved and sent to the board developing new marketing materials to be used for RFI responses, talent attraction, and templates to be localized by partners in the region. Steve and Aaron updated the board on the housing committees' activities. The discussion with CEDA and Compeer regarding small community single family developments is continuing with work focusing on Polk and Pierce Counties.

The stay campaign has wrapped up. Processing a \$16,000 reimbursement request through WEDC. The DEI conference planning was updated.

EXECUTIVE DIRECTORS REPORT

Broadband work continues with Cliff Albertson connecting with the counties. Momentum West was part of a Polk County broadband discussion and is reaching out to replicate the program if other counties are interested. Our region received 10 of the 24 statewide grants this last cycle. on May 3rd.

Site visit in a few weeks for Project Synergy. Several still alive. Two due last week but nothing from the region to submit.

Planning underway for a June 27th event on the WDB grant program in Polk County, as well as a series of events with CVTC.

Steve is part of the Dunn County EDC priorities sessions and the statewide Policy Academy.
