Board Meeting Monday February 14, 2024 at Noon Cumberland City Hall Cumberland, Wisconsin 54829

In attendance: Tom Schroeder – President, Alan Carlson MD – Treasurer, John Bavier – Secretary, Tim Defoe (on vacation) and Mike Werner

- 1. Call meeting to order at 12:03 pm
- 2. Approve minutes from Jan. 15, 2024 meeting
 - a. We haven't received the \$3,500 donation from United Fund of Cumberland, Mike Cifaldi
 - b. Mike Werner made the motion to approve, with Craig Turcott second. Approved.
- 3. Approve Treasurer's Report by Dr. Carlson:
 - a. Period ending 2/14/2024:
 - i. Beginning Balance on 1/15/2024 of \$344,515.03. Additions to the checking account:
 - 1. Jan. taxes revenue from Crystal Lake of \$549.50 and Feb. tax revenue from City of Cumberland and Town of Cumberland totaling \$70,716.79, and misc. interest of \$747.46.
 - 2. Total of \$416,528.78.
 - ii. 6 Expense checks written totaling \$217.945.75 (which includes the check to Pember Companies for Library Lake SE Phase 2 for \$205,869.75 (that excludes a small withholding pending completion))
 - iii. for a balance of \$198,583.03
 - iv. Additional Savings account, and Outstanding Grants are as follows:
 - 1. Library Lake Savings Acct #108079 has \$120,680.44.
 - 2. 3 outstanding Grants, totaling \$241,062.50.
 - b. Motion to approve Treasurers report by Mike Werner, and seconded by Doris Laursen. Approved.
- 4. Recognition of John Thon as visitor.
- 5. Discuss 2024 EWM Treatment Plan and approve treatment contracts with Lake Restoration and Aquatic Plant Management
 - a. Getting pushback from the DNR on ProcellaCor treatment option for treating navigational access. This issue will need to be revisited in the near future.
 - b. DNR won't allow access to areas closer than 30 ft from shore for navigational access.
 - c. We previously budgeted at the \$180,000 amount for EWM treatments for the year, with an expectation of needing about \$65,000 this year.
 - d. Over the long haul, it is much more cost effective to treat it every year, to keep it under control.
 - e. Dr. Carlson moved to approve both estimates, with a second from Craig. Approved.
- 6. Approve Endangered Resource Services, LLC Plant Survey contract for 2024
 - a. Matt's cost was \$9900 last year, and quote is for \$10,680 this year.
 - b. Doris made the motion to approve, Mike seconded. Approved.

- 7. Approve annual membership with the Cumberland Chamber of Commerce
 - a. Cost will be \$125/year (5 memberships). Mike Werner made a motion, and Tim Defoe seconded. Approved
- 8. Update on 2024 Grant applications for Phase 3 SE storm water Pond grant award and Greater Beaver Dam Lake Management Plan
 - a. The Phase 3 grant application was awarded for \$126,187.00 with a total of \$168,250.00 with the Lake Districts 25% match. We didn't get the grant for the Great Beaver Dam Lake Management planning grant.
 - b. Tom Schroeder will thank United Fund (Mike Cifaldi) at the meeting next Tuesday week and will present a request consideration of a donation for Library Lake dredging at that time.
- 9. Update on the North Library Lake Dredging permit
 - a. The dredging permit for North Shore of Library Lake was received on Feb. 5th. Anyone with a grievance can petition DNR, within 30 days which would cause a review.
- 10. Update on Fund raising for Dredging Library Lake (Mike Werner)
 - a. Email went out yesterday.
 - b. They will meet sometime next week for next steps.
- 11. Open discussion no action to be taken by Board
 - a. Need a date for the Annual Meeting. We will decide next month. August may be a good month.
 - b. At the Annual Meeting, there may be a discussion on rentals around the lake.
 - i. Tourist Rental Discussions, with clauses about RV's, parking, etc.
 - 1. Doris has heard about some homes being specifically bought for VRBO year-round use.
 - 2. County has started putting in ordinances about VRBO's.
 - c. Wake Boats will be a discussion point at the Annual Meeting.
 - d. There is an opening for one commissioner to attend the 2024 Wisconsin Lakes and River Conference in April 10-12 in Stevens Point.
 - e. John Thon asked about the timing of the 63 bridge redo. Now expected for 2026, with DNR and DOT working through issues.
- 12. Set next meeting date: TBD. Tom will be on vacation until April 4th.
- 13. Motion to adjourn. Adjourned at 12:50 p.m.
