














In September 2024, 69 cases were closed. Of those cases, 19 defendants were sentenced to probation in 24 cases and three defendants were sentenced to prison with extended supervision.

#### Of the 24 cases:

- 4 defendants ordered one year of probation
- 11 defendants ordered two years of probation
- 6 defendants ordered three years of probation
- 3 defendants ordered four years of probation
