<u>Background</u>: The Rural Transportation Work Program (RTWP) highlights potential 2026 transportation related projects and associated work in the seven-county region, not including the Eau Claire-Chippewa Falls urban area. These tasks include working on different projects with communities, counties, State of Wisconsin, Federal government, and/or other regional partners. The types of projects can include all modes of transportation. The WCWRPC is required to adopt the RTWP every year, which is typically done through the process of adopting the preliminary budget.

<u>Potential Action</u>: Affirm the adoption of the 2026 RTWP as reflected in the 2026 Preliminary Budget Approval.

7. 2025 Economic Development Administration (EDA) Comprehensive Economic Development Strategy (CEDS) Document Approval – Executive Director Scott Allen/Frank

<u>Background</u>: As per EDA requirements, every five years WCWRPC must submit an updated CEDS document for the region. The updated document will be presented for discussion and approval. <u>Potential Action</u>: Review CEDS and approve resolution for adoption.
