Meeting called to order by Judge James Babler at 11:59 a.m. Public meeting notification read by Babler. Motion Okey/Roux to approve agenda moving #6 to top.

Babler presented Barron County Family Recovery Court short video. Council discussed. Babler presented number of children in out-of-home placement in Barron County from 2018 to present date. Council discussed. Stated participation in Family Recovery Court is voluntary. Stated court is held every two weeks. Stated there is a team staffing and in court face-to-face time with each participant. Council discussed.

Karla Broten, Youth and Families Program Manager with Barron County DHHS, presented process of enrollment in Family Recovery Court. Stated potential participants are introduced to program and presented with video at meetings with social worker. Council discussed.

Motion Millermon/Evenson to approve minutes. Motion carried.

Fitzgerald presented all data reports. Coordinator explained new breakdown for probation holds on jail data reports. Council discussed.

Coordinator presented 2025 TAD Grant update. Stated Barron County received \$150,000 from state, and \$50,000 required match from Barron County. Stated some restrictions with incentives being funded by the state this year. Stated treatment team is working on alternatives. Turcott asked if grant funds trainings. Coordinator stated grant covers trainings at no additional expense to Barron County.

Future agenda items: Competency Subcommittee Update

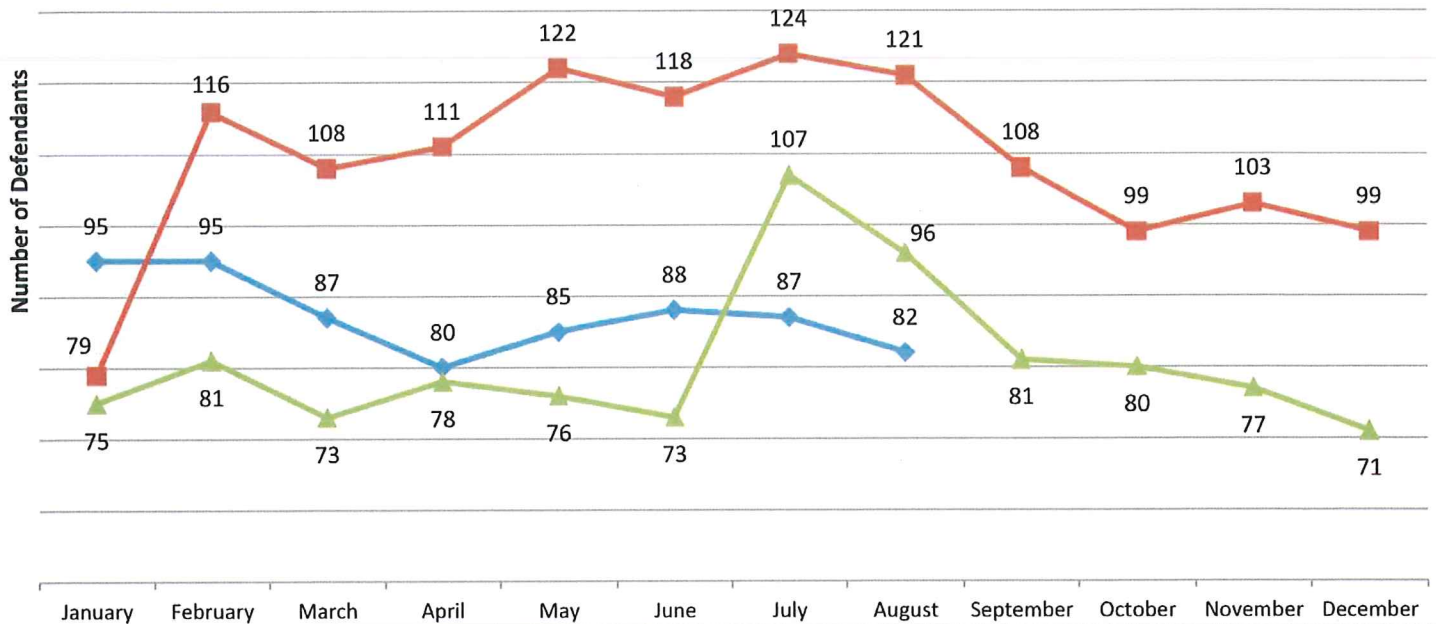

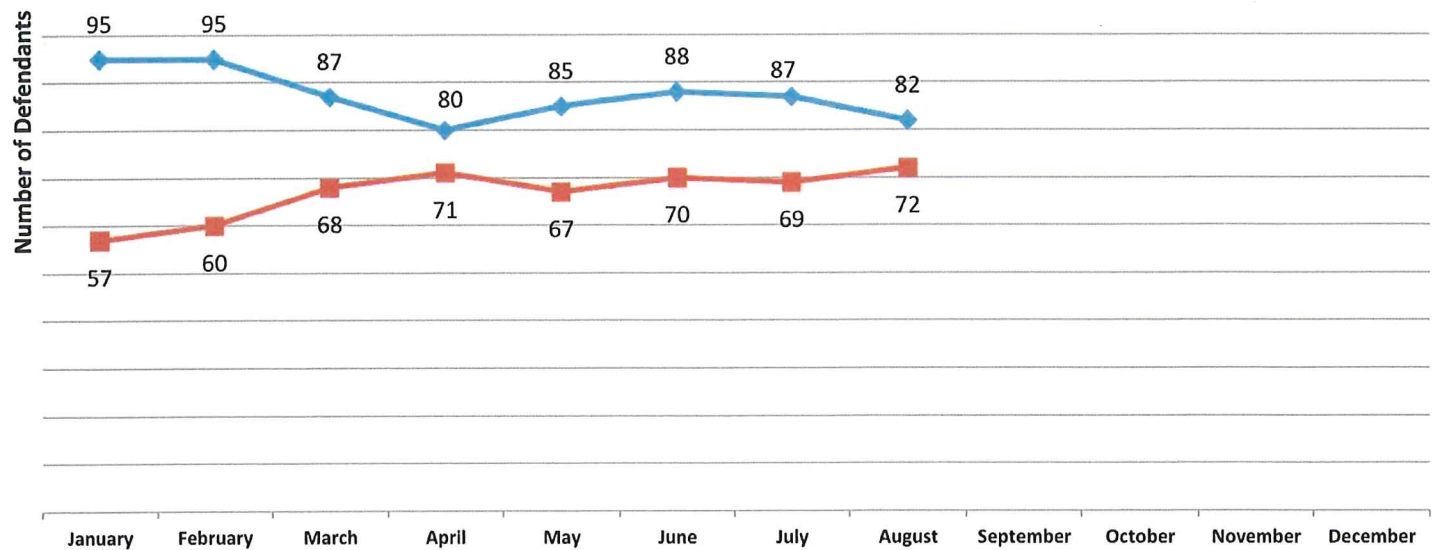
## Barron County Average Daily Population Comparison

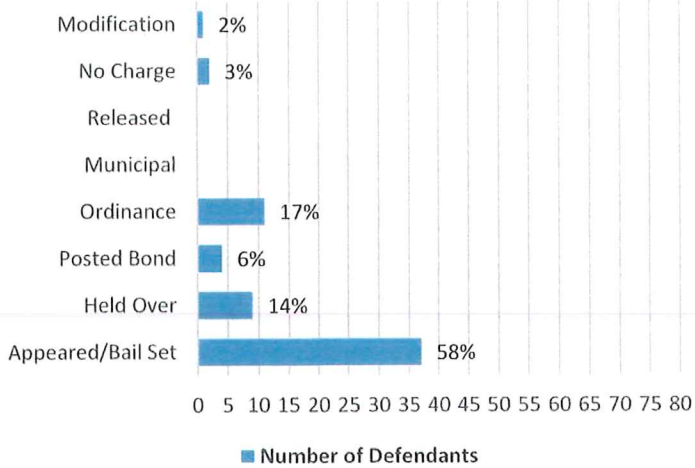
## Barron County 2025 Average Daily Population

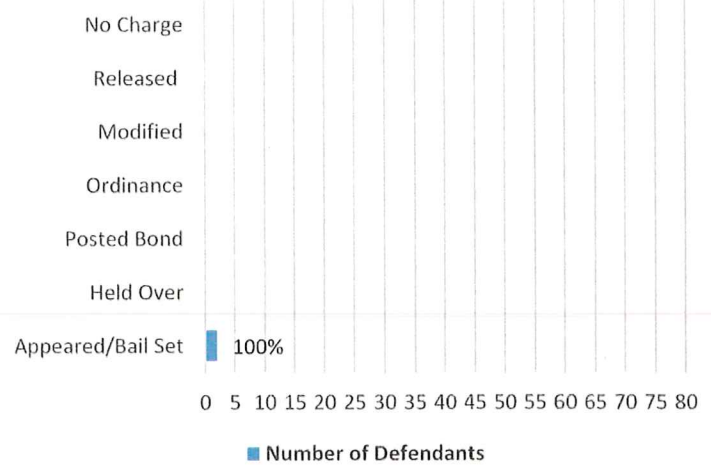




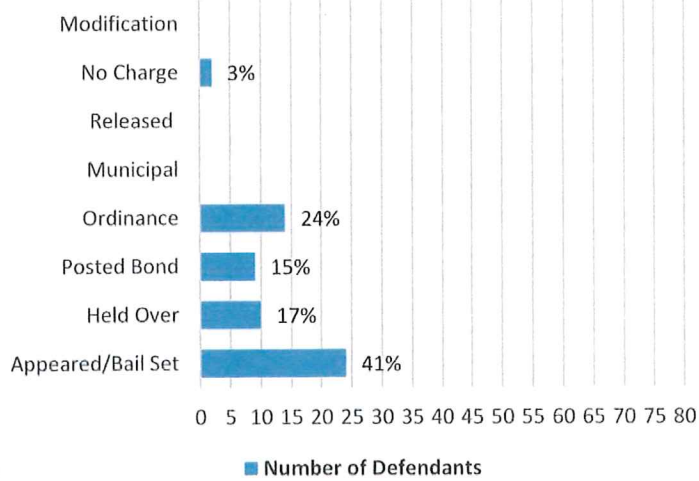
Barron County May 2025 Jail Roster Summary



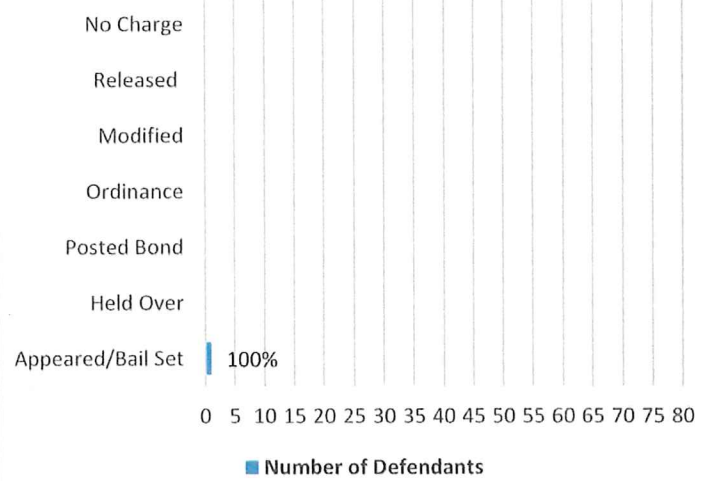
Barron County May 2025 Bail Jumping Charges



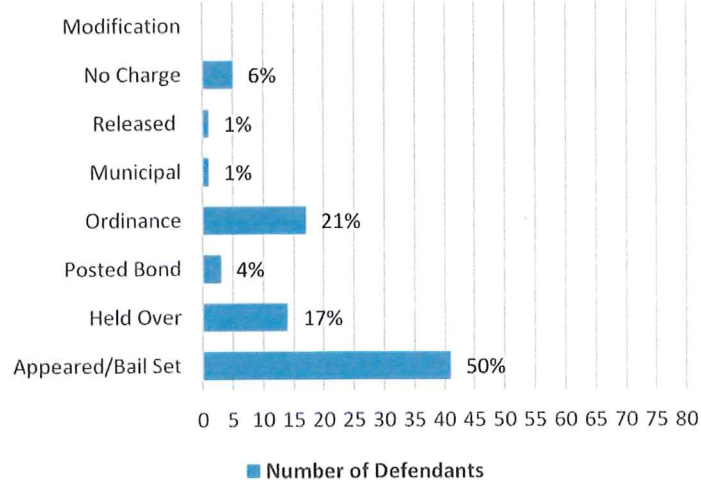

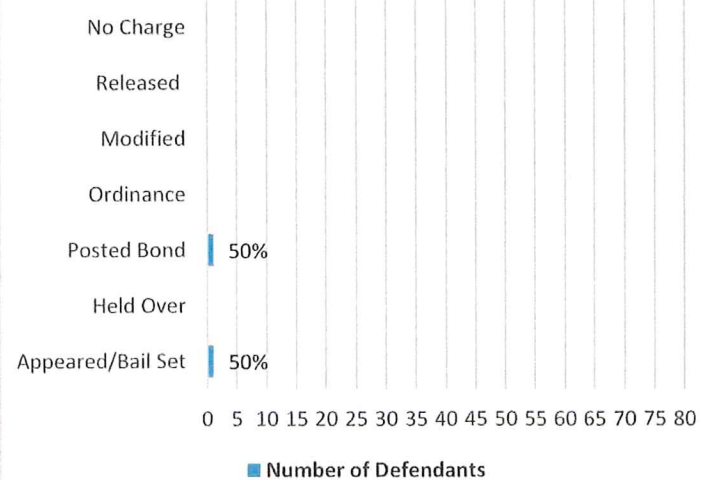
Barron County June 2025 Bail Jumping Charges



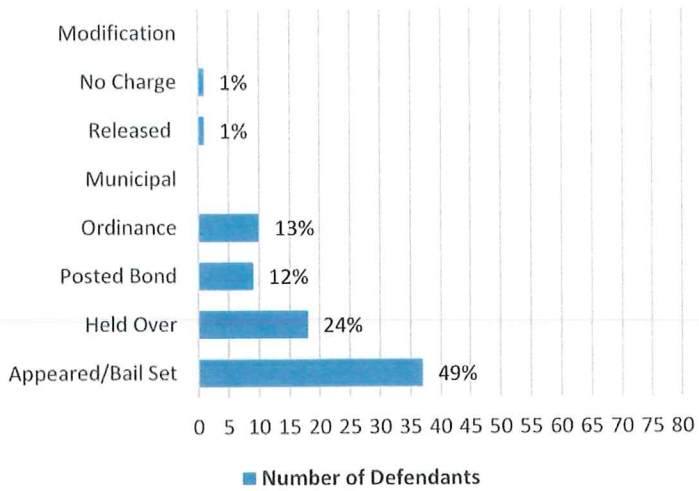

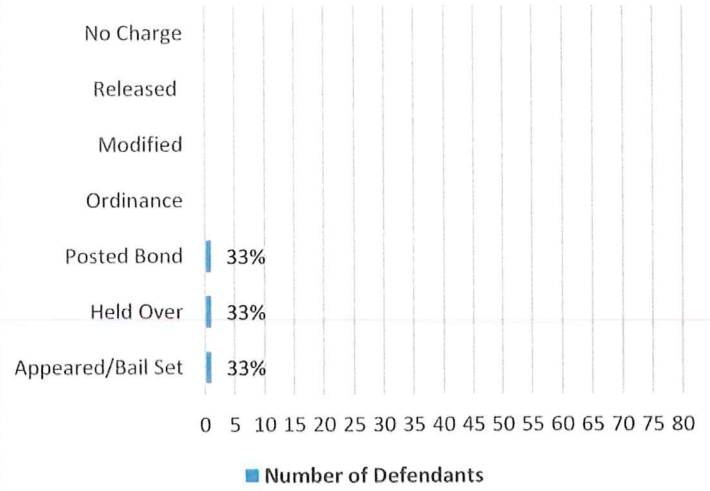

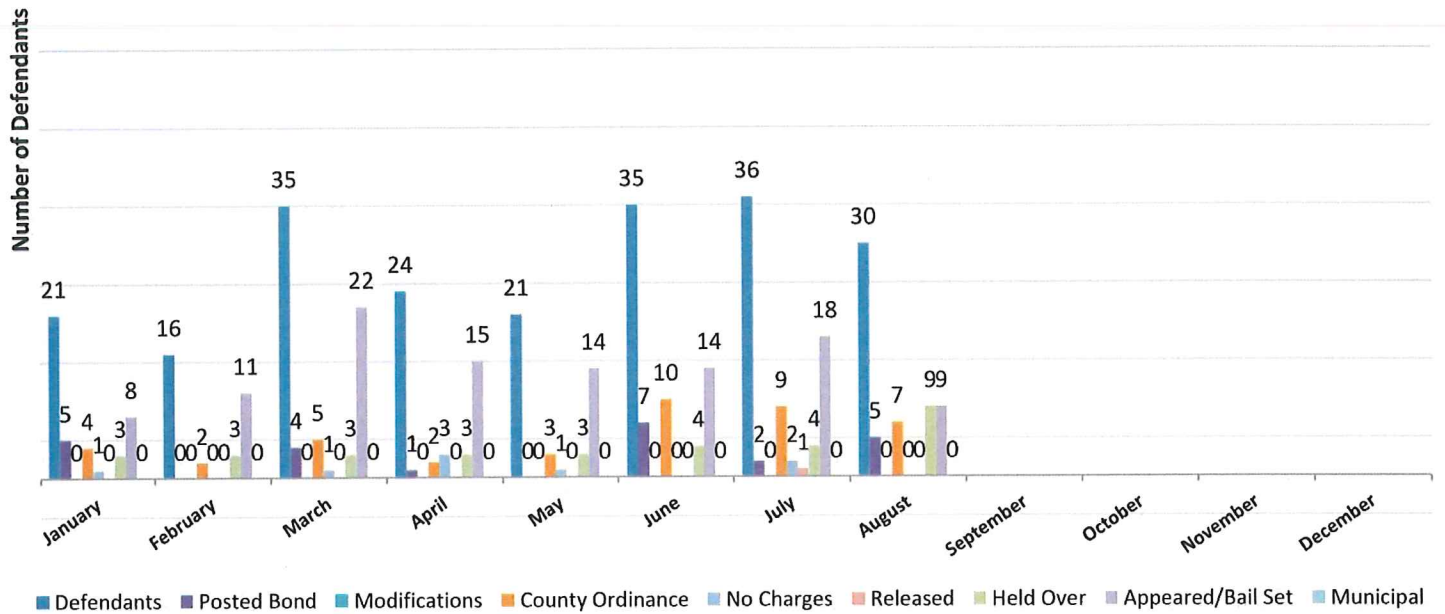

## Barron County 2025 Hold Over Summary



In May 2025, 92 cases were closed. Of those cases, 28 defendants were sentenced to probation in 32 cases and two defendants were sentenced to prison with extended supervision.

Of the 32 cases:

- 12 defendants ordered one year of probation
- 12 defendants ordered two years of probation
- 7 defendants ordered three years of probation
- 1 defendant ordered four years of probation

In June 2025, 92 cases were closed. Of those cases, 28 defendants were sentenced to probation in 31 cases and two defendants were sentenced to prison with extended supervision in two cases. One defendant is eligible for expunction.

Of the 31 cases:

- 4 defendants ordered one year of probation
- 17 defendants ordered two years of probation
- 7 defendants ordered three years of probation
- 2 defendants ordered four years of probation
- 1 defendant ordered five years of probation

In July 2025, 73 cases were closed. Of those cases, 21 defendants were sentenced to probation in 22 cases and two defendants were sentenced to prison with extended supervision in two cases.

Of the 22 cases:

- 4 defendants ordered one year of probation
- 11 defendants ordered two years of probation
- 6 defendants ordered three years of probation
- 1 defendant ordered five years of probation

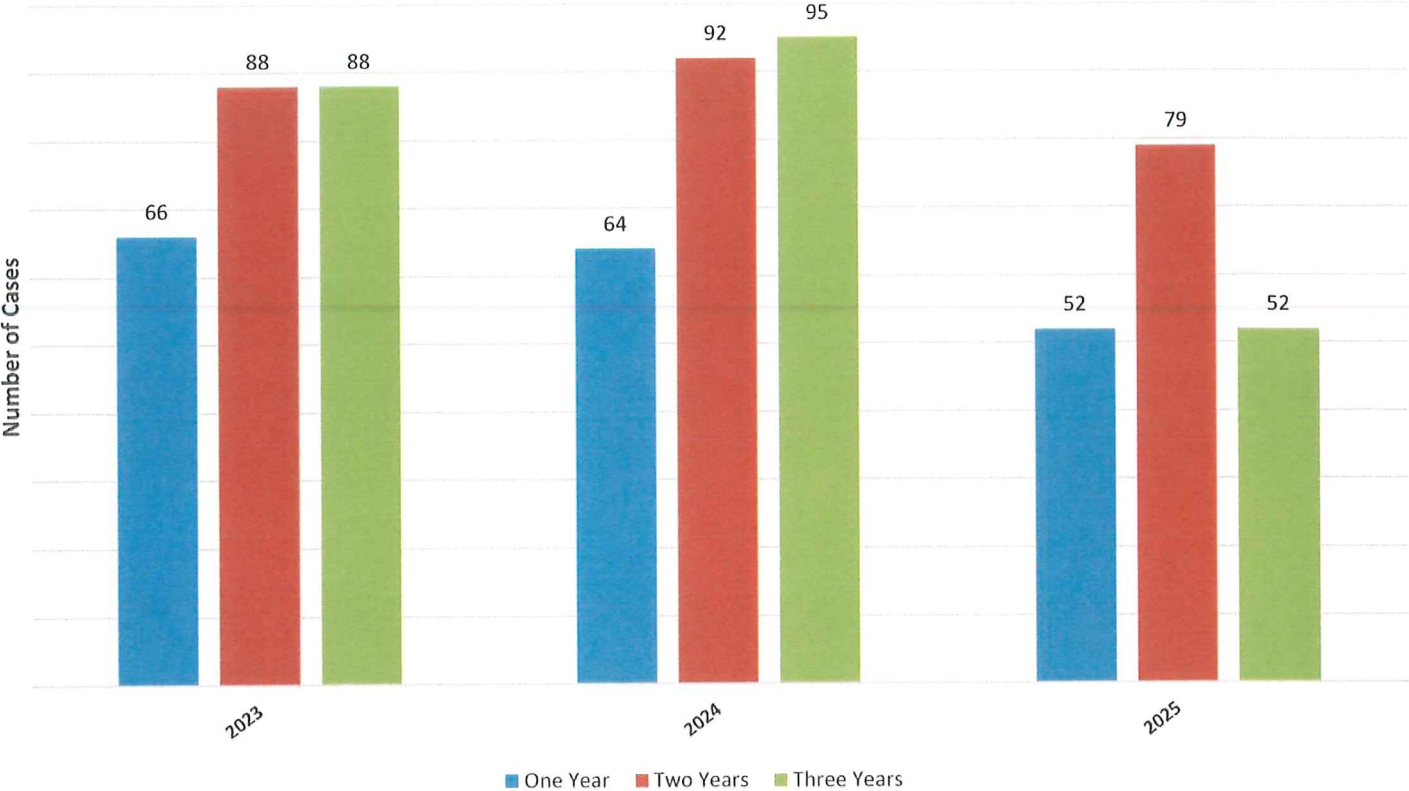
In August 2025, 92 cases were closed. Of those cases, 33 defendants were sentenced to probation in 35 cases and one defendant were sentenced to prison with extended supervision in two cases. Four defendants are eligible for expunction.

Of the 35 cases:

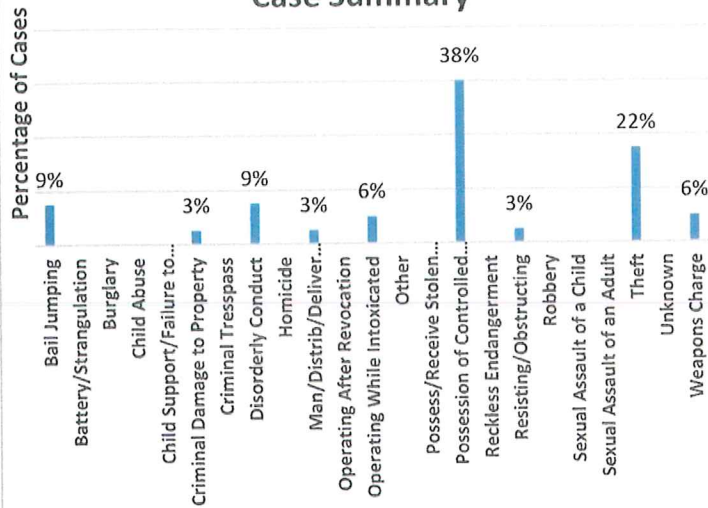
- 11 defendants ordered one year of probation
- 1 defendant ordered 18 months probation
- 11 defendants ordered two years of probation
- 1 defendant ordered 30 months probation
- 10 defendants ordered three years of probation
- 1 defendant ordered four years of probation



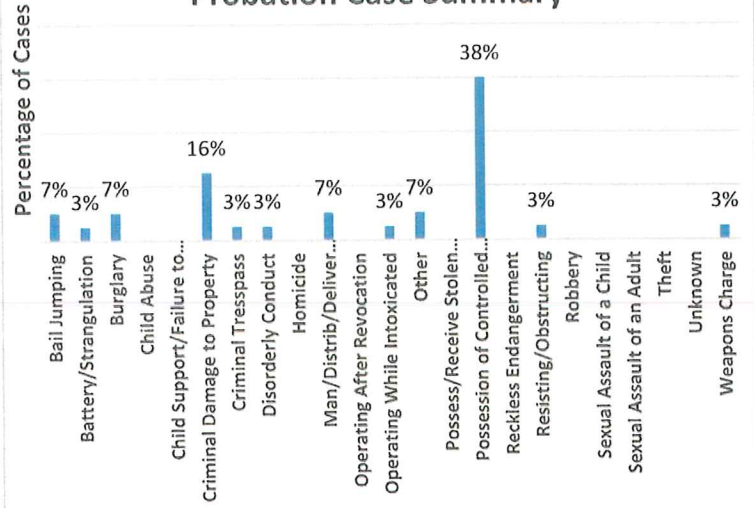
Barron County Probation Term Comparison



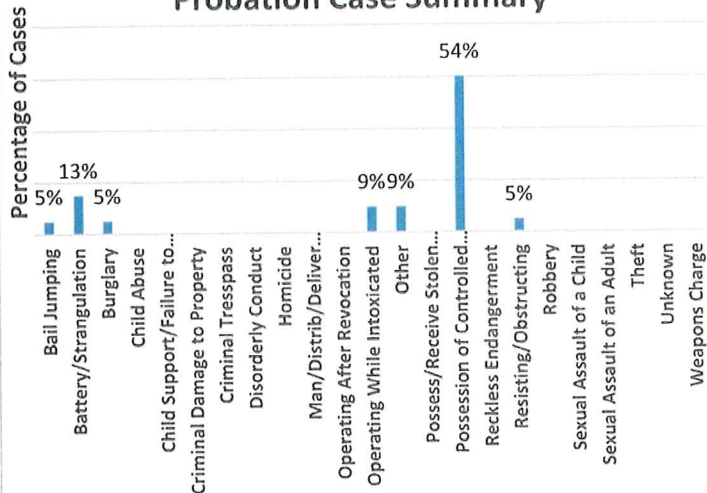

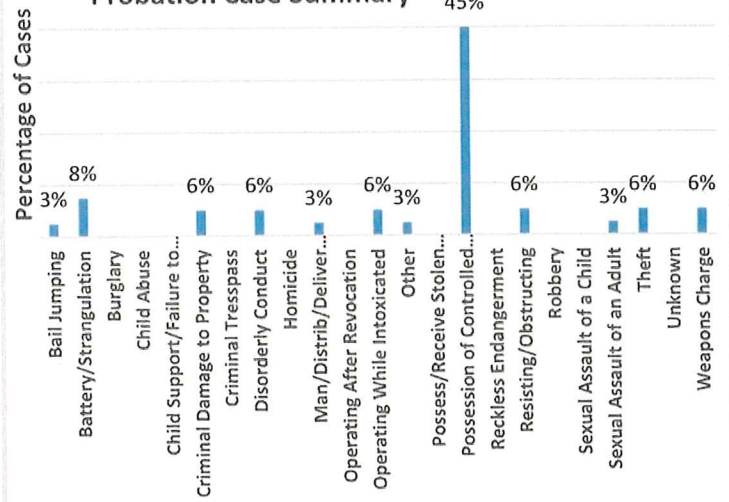

## Inmate Crime Classification



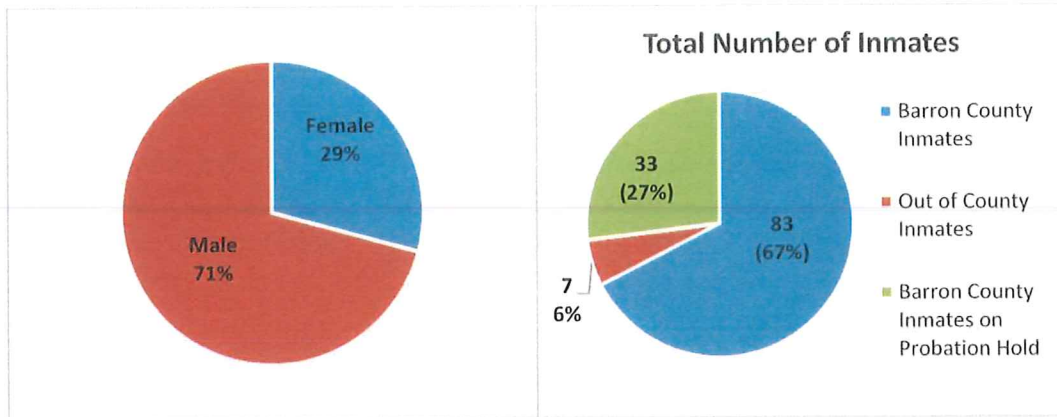

## Inmate Crime Classification



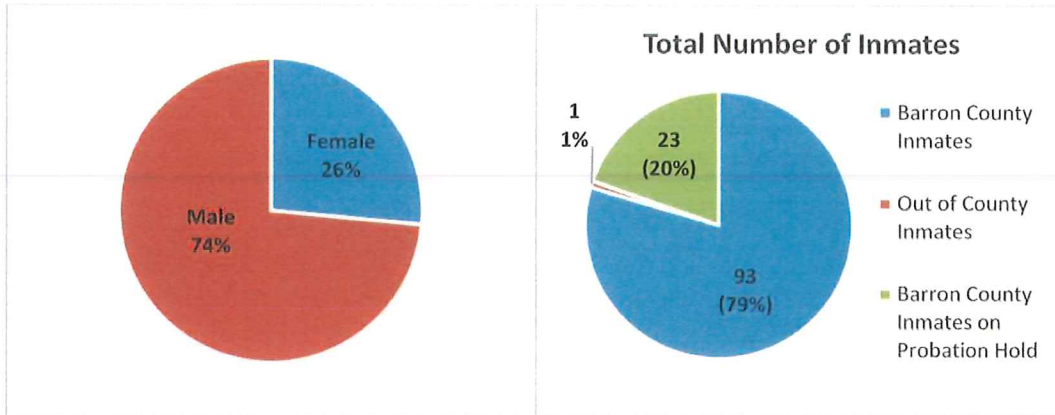

Subject: Operating After Revocation Diversion Program Summary

The Barron County OAR Diversion Program is a diversion program for offenders who have been issued a citation for Operating While Revoked, Failure to Install Ignition Interlock Device, and/or Operating Without a Valid License. The goal of this program is to assist first time offenders in obtaining a valid driver's much more quickly and efficiently. The benefits of the program are both time and money related:

- No criminal complaints; DA's office and Clerk's office save time in processing
- Fewer offenders appearing at intake court saving time for all court personnel
- No need for counsel, providing more access to public defenders and saving State and County taxpayers expenses
- Offender is able to obtain a license without costs related to attorney's fees or taking off work to appear in court

From 2016 through 2024, 329 referrals were made to the OAR Diversion Program. Of those referrals, 129 offenders (40%) successfully completed the Diversion Program.
