1	WHEREAS, Mosaic Technologies, Inc. (Mosaic) located in Cameron, Wisconsin i		
2	interested in applying for and receiving a State of Wisconsin Broadband Expansion Grant, a		
3	announced by Governor Tony Evers on November 9th, 2021, to expand broadband infrastructure		
4	high-speed fiber lines primarily in the Township of Prairie Lake (North Chetek Fiber Expansion
