

**BARRON COUNTY RESOLUTION NO. 2024 - 26**

**Fees Charged by the Sheriff**

**TO THE BARRON COUNTY BOARD OF SUPERVISORS:**

1  
2       **WHEREAS**, pursuant to sec. 814.70, Wis. Stats., the Sheriff may collect fees of  
3 specific amounts for various duties and responsibilities assigned to that office; and

4  
5       **WHEREAS**, sec. 814.705 allows a County Board to establish higher fees for  
6 certain of those duties and responsibilities assigned to the Sheriff; and

7  
8       **WHEREAS**, the Sheriff’s Department expends considerable manpower hours to  
9 provide those duties and responsibilities; and

10  
11       **WHEREAS**, a review of the fees charged reveals that it is appropriate to increase  
12 certain fees to adequately recover the reasonable cost and expenses incurred; and

13  
14       **WHEREAS**, it is the recommendation of the Law Enforcement/Emergency  
15 Management Committee that the County Board of Supervisors authorize higher fees to  
16 adequately compensate the Sheriff’s Department for the services rendered; and

17  
18       **WHEREAS**, this resolution was approved by the Law Enforcement/Emergency  
19 Management Committee on May 24, 2024, on a vote of 7-0, with Olson, Okey, Mosentine,  
20 Turcott, Anderson, Schneider and Wenzel voting in favor and no members voting against.  
21 Bergeson was absent; and

23       **WHEREAS**, this resolution was approved by the Executive Committee on June 5,  
24 2024, on a vote of 9 - 0, with B. Anderson, Bartlett, Cook, Hanson, Heller (alternate),  
25 Kusilek, Okey, Nelson (alternate) and Wenzel voting in favor and no members voting  
26 against. Thompson and Rogers were absent.

28       **NOW, THEREFORE, BE IT RESOLVED**, that the County Board of Supervisors  
29 does authorize the Sheriff to charge fees pursuant to the following schedule, and require  
30 prepayment unless an open account has been established with the Sheriff’s Department, or  
31 it is a Government Agency:
